PATIENT AND VISITOR NAVIGATION

She stated the overall goal was to create an effective wayfinding system that would move patients and visitors confidently through campus parking logs and facilities to their final destinations. Ms. Woods shared examples of the plans for a color-coded system for consistent identification of geographic zones and key areas with further assistance from using northwest themed icons. She concluded with next steps and an installation planned for June-August this year.

Mr. Gary Baldridge and Mr. Marty Andrews presented their information regarding a potential redesign and strategic planning of Skagit Regional Health's long term health program to a proposed self-funded/self-insured plan.
